REAL ID Timeline May 2005 - Congress passed REAL ID Act June 2007 - Washington legislation prohibiting spending funds to comply with REAL ID until federal funds received and other requirements met January 2008 - REAL ID rules published December 2009 - Original compliance deadline May 2011 - Extended compliance deadline October 2012 - Deadline for certification filing
