EPIC also pays Medicare Part D plan premiums, up to the amount of a basic plan, for members with annual income below \$23,000 if single or \$29,000 if married Those with higher incomes must pay their Part D plan premiums • To help them pay, their EPIC deductible is lowered by the annual cost of a Medicare Part D basic plan
