Roughly three-quarters of US tax filers typically end up getting a refund after they file their federal income tax returns. Last year 77% of filers got one, and the average refund was \$2,549

In other words, a deduction "reduces your income in arriving at taxable income," says Charlene Wehring, certified public accountant, financial advisor and founder of Wehring Wealth Management in Bellville, Texas. "And then you apply your (tax) bracket." That's in contrast to a tax credit, which lowers your tax liability dollar for dollar.
